OPERATE A BADMINTON SUPPLY SHOP AT 101 CASCADE ROAD, SOUTH HOBART, TASMANIA

The Southern Tasmania Badminton Association (STBA) wishes to invite expressions of interest for provision of services as outlined below;

Required

- 1. Operation of a Badminton Supply Shop (hereafter referred to as the Shop) on the STBA premises at 101 Cascade Road, which would include
 - Stockist of equipment required to play the game of badminton as an individual, including but not limited to, racquets, shoes, grips, and bags.
 - Please note the STBA orders shuttles to ensure players can continue to play, however, this does not restrict the shop from also selling shuttles.
 - The range of equipment should be suitable for use by players of all abilities and experience.
 - Provision of racquet stringing services, including the sale of strings, and provision of an after-hours drop off and pick-up service.
 - This could also include assistance from the STBA staff and reception.
- 2. Shop must operate during all STBA-held competitions, including but not limited to;
 - Pennants and rosters (minimum of 1.5 hour's continuous operation past the commencement time of the pennant);
 - Tournaments (operating for a minimum of 75% of the expected tournament duration, ensuring it is opened before the tournament begins).
- 3. Shop hours of operation must be clearly displayed to STBA members on the physical premises and in any online or printed marketing.
 - o Advertised shop hours are to be strictly adhered to.

Desired

- 1. Stocking of a minimum of 2 major badminton equipment brands in the shop.
- 2. Use of technology to effectively communicate with members around service and equipment.

Tenders must be lodged and address the above Tender Conditions , noting that these have been set following feedback received from STBA members. Part of the arrangement is that the below-commercial rental rate of \$1,500.00 per year is in exchange for keeping stringing prices low.

Please note that tenders must contain detailed information on how the applicant intends to operate their business to meet the tender criteria, including costs and time frames for stringing services.

For reference, we have provided a copy of the key terms of the lease in Appendix 1. Please note, that this is provided for guidance purposes, and may be subject to negotiation with the successful applicant depending on the amount of space desired by the applicant.

Please submit all tenders to the email address above, the closing date for tenders will be on the 20th May 2023, at 5 PM, and we endeavour to notify applicants of the outcome as soon as possible after they have been reviewed by the STBA management committee

Item 5	Expiry Date	Two (2) years from the Commencement Date
Item 6	Rent	\$1,500.00 each year payable by equal monthly instalments in arrears of \$125.00.

Item 8	Payment Date	The last day of each month.
Item 9	CPI Adjustment Dates	Not applicable
Item 10	Permitted Use	The sale of sporting goods and fitness/health supplements but excluding general foodstuffs and alcohol.
